DUE TO THE COVID-19 PANDEMIC, THE MASTERWORKS SERIES PROGRAMS WERE LIVE-STREAMED IN THE NEW ASO DIGITAL PLATFORM SYMPHONY+ (SYMPHONYPLUS.ORG) FROM THE MUSIC CENTER AT STRATHMORE IN MARYLAND WITH NO LIVE AUDIENCE. IN ORDER TO KEEP ADEQUATE PHYSICAL DISTANCE ON STAGE, THE ASO HAD NO MORE THAN 40 MUSICIANS ON AVERAGE ON STAGE WITH NO WINDS NOR BRASS, EXCEPT FOR THE LAST PROGRAM, FOR ALL REHEARSALS AND PERFORMANCES. STRICT COVID PROTOCOLS WERE FOLLOWED ACCORDING TO THE RECOMMENDATI OF THE ASO COVID TASK FORCE. (CONTINUED ON SCHEDULE O)

THE ASO CONTINUED ITS PROGRAMMING FOR YOUTH AND FAMILY AUDIENCES. UNFORTUNATELY, THE FOUR EDUCATION CONCERTS PERFORMEE FOR SECOND GRADERS AT MARYLAND HALL AND THE FAMILY CONCERT THE LIFE & TIMES OF BEETHOVEN WERE CANCELLED DUE TO THE PANDEMIC. ANOTHER KEY ELEMENT OF THE EDUCATION OUTREACH INITIATIVES INCLUDES THE ADOPT-A-SCHOOL PROGRAM. THE ADOPT-A-SCHOOL PARTNERSHIP CONTINUED WITH ANNAPOLIS MIDDLE SCHOOL AND THEIR PERFORMING AND VISUAL ARTS PROGRAM, BRINGING PROFESSIONAL ASO MUSICIANS IN TO THE SCHOOLS TO MENTOR MUSIC STUDENTS. UNFORTUNATELY, THE MUSIC VAN PROGRAM WHICH TYPICALLY PROVIDES APPROXIMATELY 700 ANNE ARUNDEL COUNTY THIRD GRADERS THE OPPORTUNITY TO LEARN ABOUT THE INSTRUMENT FAMILIES, MEET MUSICIANS WHO PLAY THEM, AND ENCOURAGE PARTICIPATION IN SCHOOL MUSIC PROGRAMS WAS ALSO CANCELLED DUE TO THE PANDEMIC. OTHER OUTREACH ACTIVITIES INCLUDED THE FREE SUMMER POPS CONCERT, AN OUTDOOR FULL SYMPHONIC CONCERT PRESENTED ON LABOR DAY WEEKEND AT QUIET WATERS PARK. (SEE SCHEDULE O)
