OUR SMALL ENSEMBLE PERFORMANCES PROVIDE A COMMUNITY SERVICE TO RETIREMENT HOMES, ASSISTED LIVING CENTERS, MENTAL HEALTH FACILITIES, ADDICTION FACILITIES, COMMUNITY CENTERS, HOSPITAL EVENTS, AND WE PERFORMED A TOTAL OF 24 TIMES IN THE YEAR. MANY MORE HOURS ARE SPENT PERFORMING IN THE COMMUNITY THAN SPENT IN A CONCERT HALL. THE ASO IS COMMITTED TO MAKING MUSIC AND CONCERTS ACCESSIBLE AND IT PROUDLY SHARES TICKETS TO ALL ITS CONCERTS WITH THE UNDERSERVED COMMUNITIES TO HELP BRING MORE MUSIC TO MORE PEOPLE.
